

My organisation's digital strategy is definitely on track



My organisation's digital strategy is driven mostly by our own needs, rather than by compliance and reporting requirements to the









My organisation has the capacity (people, money) and capability (knowledge) to create and deliver our digital strategy







Care Minutes: The RAC Data Trinity

Automation is critical to stay productive and operate on thin-margins

Three unique, changing, linked sources of data must be combined. Repeatably. Reliably. Affordably. Actionably.

Cliché In, Cliché Out

 RECOMMENDATION: Invest in data cleansing tools. Ask your IT team about middleware or data transformation ("ETL") tech. We need to create clean, 'joined-up' data.

The Killer Workaround

 RECOMMENDATION: Only use Excel approach temporarily. Have a clear plan to replace it with a proper set of tools. Spreadsheets aren't digital assets; they are digital debt.



- **RECOMMENDATION:**

Start mapping *your* Al Use-Cases. Must also focus on ethics, consent, data governance and guardrails.

- 1. Predictive Analytics for Patient Outcomes: All can analyze vast amounts of patient data to predict health deterioration and recommend proactive interventions, reducing hospital readmissions and improving patient quality of life.
- 2. Enhanced Resource Management: Al optimizes staffing and resource allocation by predicting demand, ensuring that facilities are adequately staffed and resources are utilized efficiently, leading to cost savings and improved care delivery.
- 3. Personalized Care Plans: By leveraging Al, care providers can create highly personalized care plans tailored to individual patient needs, preferences, and health conditions, enhancing patient satisfaction and outcomes.

Why is the government's biggest sector tech-investment in their own APIs? Enabling non-linear, scalable business operations.

B2G(2B) - Business to Government. And Back to Business (hopefully).

- **\$1.4 billion** for Aged Care digital strategy in the FY25 budget.
- Investment to **build out digital capability**. Indirectly helps providers
- **Digital "Realisation"** Government Provider Management System (**GPMS**) (portal for humans) and **B2G** API Catalogue (portal for computers)
- "Interoperability". Most roads eventually lead to sharing data through our Electronic Health Records. Learn how to pronounce it, it's tricky.

WHAT'S IN IT FOR ME (US)?


- Initially, cost, complexity and risk. Software upgrades, new/retire business processes, data quality, change fatigue, immovable deadlines and short notice
- 1-2 Year Horizon: Increased quality/efficiency, reduced risk, reduced cost
- GOAL: "Press a button" regulatory compliance every X days
- **Now:** Self-service in **GPMS**, B2G APIs for RN Minutes and Quality Indicators (RAC)
- Coming Soon: B2G APIs for QFR, Care Minutes, AN-ACC, Transfers, Support@Home

RECOMMENDATION: Directly engage (now) with your CMS/CRM vendors to discuss their roadmap for departmental "API conformance", API integration roadmap and reform readiness (e.g. new RAC funding, support@home, etc)










Opportunity for AI in Aged Care
