Total care time and RN time declined from April to May with total time decreasing -3.02% and RN time decreasing -3.44%. AIN Minutes + EN Minutes showed the biggest movement, decreasing -4.72%. Average Daily Subsidy reduced by -\$0.38 or -0.14%. And occupancy increased by 0.04%.

Minutes are measured as the actual worked minutes based on time and attendance and averaged across the number of days in the month and the total number of resident bed days for the month. Average Daily Subsidy is the average subsidy entitlement for all residents including respite but excluding defaults. Assessment activity is based on AMO assessment activity that eventuates in a paid AN-ACC claim and the entitlement start date. AN-ACC Age is the percentage of claims which have not been reassessed for more than 12 months.



The percent of permanent resident stays under six months declined significantly, and continued a trend which has seen this measure drop -8% from February last year.
